## NDC TERMINAL RULES WHEN CHECKING IN

Our checking in & safety rules are compliant with all national and international safety rules applicable in our sector.

Individual Protection Devices (DPI) must be worn AT ALL TIMES while inside our terminal, and are the same that are contained into each product handling safety data sheet (MSDS).

Please note that it is hauliers' responsibility to supply their drivers of DPI, ( Individual Protection Devices ) as well as training courses and all information needed to load at the terminal.

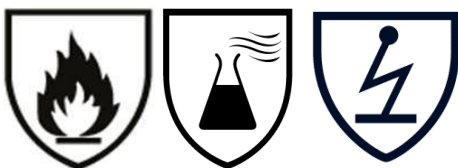
Neri Depositi Costieri shall supply all specific information regarding all risks on site. The terminal is equipped with proper posters and maps underlining all prohibitions and mandatory rules prescribed below, the road system to be respected as well as dangers (a safety movie is on going at the gate entrance while terminal is open, showing all most important safety instructions).

Neri Depositi Costieri is constantly monitoring the activities of the drivers and guarantees the continuous presence and assistance of its trained personnel.

Any wrongful behavior or breach of safety regulations shall be fined and persecuted.

When entering the terminal and during all time of stay inside the terminal, the following DPI equipment must be worn:

1. PROTECTIVE HELMET
2. ANTISTATIC CLOTHING RESISTANT TO HEAT AND CHEMICALS
3. SAFETY BELT when over the truck
4. PROTECTIVE GLOVES RESISTANT TO CHEMICALS
5. SAFETY SHOES
6. SAFETY GOGGLES OR PROTECTIVE VISOR

## PROHIBITIONS

When entering the terminal and during all time of stay inside the terminal, the following behaviours are forbidden:

- It is absolutely forbidden to bring mobile phones and any other type of electronic devices (cameras, laptop, etc). All such equipment must be left at the entrance inside the lockers and taken back when exiting the terminal gate;
- It is strictly forbidden to smoke anywhere and anytime inside the terminal;
- It is forbidden to behave or act differently from the prescribed behavior for each maneuver, as well as to act in a way that could endanger anybody else' safety;
- It is forbidden to leave any personal item (garbage and waste included) anywhere inside the terminal.

## MANDATORY RULES

- Before entering the terminal gate, trucks must be equipped with flam arresting devices;
- Truck's electronic equipments must be switched off at all times during loading operations;
- Handrail must be positioned when personnel is over the truck for loading ; in this case the driver mast wear the safety belt .
- Truck's bottom valves must be closed and blocked at all time;
- Where prescribed inside the terminal, fire proof equipment and explosion protection must be used / worn at all time
